PUBLICATION OF THE CONFERENCE MATERIALS

Proceedings of the conference (collection) and certificates of participants will be posted on the websites of the Departments of Pharmaceutical Technology of Drugs and Industrial Technology and Cosmetics of Drugs of NUPh.

REQUIREMENTS TO MATERIALS SUBMISSION

- ✚ abstracts are sent in the format MS Word: *.doc; *.docx.
- ✚ volume of thesis – up to 3 pages; volume of articles 5 to 10 full pages;
- ✚ margin - 2 cm on each side;
- ✚ font - Times New Roman, font size - 14 pt, single line spacing, space before and after the paragraph - 0 pt (absent), paragraph indent - 1,25 cm (use ruler settings);
- ✚ structure of theses: introduction, purpose of research, materials and methods, obtained results and conclusions; the first line - the name (in capital letters, bold, abbreviations of words and terms are not allowed), the second line - the surnames and initials of the authors separated by a comma (bold italics), the third line - the full name of the organization provided by the authors (in bold), separated by a line the main text of theses is printed;
- ✚ The structure of the article: UDC, the first line - the name (in capital letters, bold), the second line - the surnames and initials of the authors separated by a comma (bold italics), the third line - the full name of the organization, city, country (in bold); the materials of the

article should contain the following sections: introduction with a statement of relevance, the purpose of the research, research methods, research results, conclusions, a list of used sources (for articles in accordance with the requirements of DSTU GOST 7.1:2006);

✚ materials can be illustrated with pictures, diagrams, charts, which are submitted in JPEG format, and tables must have numbering and headings; there should be references to illustrative material in the text (see Fig. 1, see diagram 2, etc.). The number of figures and/or tables should not be more than 2. The data of the figures should not repeat the materials of the tables. Tables should contain summarized and statistically processed research materials, have a number and a title. In tables, all columns must have headings, numbers and units of measurement must correspond to the text, word abbreviations are not allowed. Abbreviations of words are allowed only with the initial indication of the full name or in accordance with the list adopted by the Standards Committee. Units of measurement are given in accordance with the International System of SI Units;

✚ scientific titles and scientific degrees of the authors are not indicated;
✚ when using the results of statistical data analysis, it is mandatory to indicate the software and its version, it should be also specified the methods of statistical processing, the level of probability when testing statistical hypotheses and calculations of the confidence interval for the main results of the study;

Abstracts should be submitted in electronic version, saved in ***doc. *docx.** format. One file must contain one paper.

Name of the file must correspond the first author (e.g. Kovalenko I.M.doc). If more than one article of an author is submitted, the files are numbered with Arabic numbers (Kovalenko I.M.1.doc).

CONDITIONS OF PARTICIPATION

Materials that do not meet the specified requirements in the design, submitted in violation of the deadlines will be returned to the authors for adjustments.

Revised materials must be returned no later than one week after submission to the authors. Unrevised materials will not be considered. The author is responsible for the content of materials.
