5. Abstract of the educational component: in the selective educational component "Technology of homeopathic medicinal products" is an important component of the training of a future specialist and a part of the general human culture. Homeopathic pharmacy is a branch of scientific knowledge and practical activity aimed at the search, creation, production, quality control, research, storage, sale, marketing of homeopathic medicines, as well as the organizational and legal aspects of providing pharmaceutical homeopathic care. Currently, homeopathy is a permitted treatment method in Ukraine. To provide homeopathic treatment, medicinal products are required, which are used in small doses and are manufactured using a special technology. The specificity of the system of homeopathic pharmacy lies in

the features of production, quality control, implementation and use of homeopathic medicines, which are closely related to the observance of the main principles of homeopathy: similarity, research of homeopathic medicines, potentiation. In this regard, the pharmacist needs to have a general understanding of the method of homeopathy, homeopathic medicines, manufacturing technologies of homeopathic medicines, regulatory documentation in the field of homeopathic pharmacy. The study of this educational component contributes not only to increasing the professional level of conducting scientific research activities, but also to increasing the culture of thinking, the culture of mental activity in general, which helps a person to better understand and evaluate reality.

6. The purpose of teaching the educational component: deepening of professional knowledge and familiarization with the theoretical and practical bases of the technology of homeopathic medicines in pharmacy conditions, quality control, rules of registration before release, storage conditions and features of use by patients.

10. Prerequisites of the educational component: the discipline is based on the study of physics, general, inorganic and organic chemistry, physical and colloidal chemistry, biology with the basics of genetics, medical botany and the technology of pharmaceutical drugs.

11. Scope of the educational component : for applicants of higher education:

(4 years, 10 months) 3 ECTS credits 90 hours: 32 hours of classroom classes, of which 6 hours of lectures, 24 hours of practical classes, 2 hours of seminar classes; 58 hours of independent work.

12. Organization of training :

Teaching methods :

- *explanatory (informational and reproductive) method:* Lecture-based learning –lectures, video materials;
- *reproductive method:* traditional practical classes;

- problem teaching: Brainstorming "brainstorming" method; Case-based learning –case method;
- *partial search method:* Game-based learning –game methods of learning (business games); Team-based learning –the method of working in small groups;
- *research method:* Research-based learning –participation in research work, preparation of theses of conference reports, scientific articles.

Content of the educational component:

Content module 1. General issues of the technology of homeopathic medicines. Technology of basic homeopathic drugs

Topic 1. Concept of homeopathy and its basic principles. State regulation of the production of homeopathic medicines. Peculiarities of prescribing homeopathic prescriptions. Nomenclature of homeopathic medicines.

Topic 2. Classification of homeopathic drugs. Preparation of homeopathic matrix tinctures according to DFU and their quality control.

Topic 3. Dilution scales. The principle of potentiation of homeopathic drugs. Potentiation of homeopathic matrix tinctures.

Topic 4. Dilutions are homeopathic. Technology of liquid homeopathic dilutions, preparation for release and their quality control.

Topic 5. Goering's law of healing. Technology of homeopathic oils, preparation for release and quality control.

Topic 6. Technology of basic drugs, liquid homeopathic medicinal forms, preparation for release and their quality control.

Topic 7. Constitutional type of the patient. Homeopathic granules. Technology of homeopathic granules, preparation for release and their quality control.

Topic 9. Complex homeopathic medicines. Technology of complex homeopathic medicines, preparation for release and their quality control.

15. Policies of the educational component:

Academic Integrity Policy . It is based on the principles of academic integrity stated in the POL "On measures to prevent cases of academic plagiarism at the National Institute of Public Health ". Writing off when evaluating the success of a student of higher education during control measures in practical (seminar) classes, control of content modules is prohibited (including using mobile devices). The detection of signs of academic dishonesty in the student's written work is a reason for the teacher not to enroll it .

Policy regarding deadlines, working out, rating increase, liquidation of academic debt.
